I hereby release, waive and discharge the Sponsors and their respective current and former officers and directors, employees, agents, subcontractors, volunteers and assigns from any and all causes of actions, claims, charges, demands, losses, damages, costs, attorneys' fees and liabilities of any kind that I may have or claim to have in any way relating to publication of the artwork, or an any and all claims I might have now or in the future concerning the use of the artwork.
